SPECIFIC INSTRUCTIONS FOR INTERNATIONAL TRACK CALENDARS

CLASSIFICATION

The class of the competition determines the points awarded to the participants as per the scale stated in the UCI regulations (**Title 3, Chapter III**).

As a reminder, it is possible to specify on the registration form the type of class (CC, CL1, CL2, Nat) for each specialisation. The races at a national level (Nat.) can be registered as a complement to the UCI competitions.

The evaluation of the competitions registered in the 2020-2021 calendar determines the class in which they will be registered for 2021-2022 season (as per art. 3.8.003).

Any event for which points counting for the UCI Track Classification are awarded will need to respect the formats and/or minimal distances as stipulated in the UCI Regulations, failing this, points will not be awarded.

With regard to the minimum criteria for **categories**, if several categories participate in the same race, the category of the majority of participants will be taken into account only.

Younger athletes or masters can participate in elite races to expand the bunch. Nevertheless, riders younger than 18 years old will not score UCI points and must not be taken into account in the analysis of the minimum number of participating nations (article 3.8.003). 18-year-olds junior riders will score UCI points in elite ranking. In any case, all athletes must be included in the results.

For the registration of **Six Days type of event**, the registered event shall be Madison (for example Men Elite Madison); each individual event of that category shall not be registered.

For others **tournament**, different from the format as regulated by the UCI, (for example Sprinter's tournament on several days) as stipulated in art. 3.3.005, points will be awarded according to the overall standings of the speciality (for example individual sprint). If the tournament is made of several events (Sprint and Keirin), the event which will award the UCI points shall be clearly identified on the program of the competition and communicated to the UCI Track Department (track@uci.ch).

We remind that as per art. 3.3.003, if more than 50% of the riders per category are being invited, the awarded points will be of Class 2 points scale.

For your information, please find hereafter two examples to illustrate how criteria are taken into account to classify an event.

CLASS 1 EVENT

The Class 1 event regulation has been updated for the 2021-2022 season.

From now on, an event registered in Class 1 will automatically obtain the Class 1 points. Events won't be downgraded anymore, ensuring more security to riders and organizers. A Class 1 event will however have to respect the following requirements to keep its' status the following year:

4 PARTICIPATING NATIONS

The number of nations considered is the event among the program in which the maximum of nations are represented. In terms of points granted to riders, any events in the program registered as Cl1, riders will be awarded points according to the scale provided for a **class 1** event.

However, if some events in the program have **only 3 nations or less** at the start, the competition will be downgraded in Class 2 or national the following year.

Attention: This analysis must be made on the basis of the riders participating in the specific category of the event only (for example a Scratch race Men Elite, nations of elite riders will be taken into account only).

EVENTS FOR MEN ELITE AND WOMEN ELITE

plus 1 other categorie to be chosen from Men or Women U23, Men or Women Junior, or Para-cycling.

The requirement of events for **4 categories** to be organised within the competition's programme take into account all events organised, **even national event or those with one country represented at the start**. Different categories can be combined in one race. Nevertheless, the category of the majority of participants will be taken into account only. Participants belonging to another category must be included in the results but will not receive UCI points.

5 COMPETITIONS MINIMUM

(event part of the World Championships programme in one category).

The requirement of competitions take into account any event's type represented at the World Championships, regardless of the number of nations at the start of those events.

<i>Example of possible minimum programme for a class 1 event</i>	
MEN ELITE	Points race (8 nations at the start) → eligible for class 1 points
WOMEN ELITE	Sprint (3 nations at the start) → eligible for class 2 points
WOMEN JUNIOR	Scratch (2 nations at the start) → not eligible for points
MEN U23 Madison	(4 nations at the start) → eligible for class 1 points
MEN ELITE	Scratch (5 nations at the start) → eligible for class 1 points
With 4 categories, a maximum of 8 nations in one event and 5 competitions, such an event would be classified in class 1.	

<i>Example for a Six Days type of programme</i>	
MEN ELITE	Madison
WOMEN ELITE	Scratch (even though there is a tournament with Points Race, Scratch and Time Trial; Scratch is identified as the race that will award UCI points)
MEN JUNIOR	Omnium (as per regulations)
MEN ELITE	Sprint tournament (overall standing will award UCI points)

CLASS 2 EVENT

This class event must fulfil the following criteria:

3 PARTICIPATING NATIONS

The number of nations considered is the event among the program in which the maximum of nations are represented.

In terms of points granted to riders, any events in the program where **at least 3 nations** are competing, riders will be awarded points according to the **scale** provided for a **class 2** event.

If some events in the program have **between 1 to 2 nations** at the start, **no points will be awarded** to riders competing.

EVENTS FOR MEN ELITE OR WOMEN ELITE

plus 1 other category to be chosen from Men or Women Elite, Men or WomenU23, Men or Women Junior, or Para-cycling.

The requirement of events for **2 categories** to be organised within the competition's program take into account all events organised, **even national event or those with one country represented at the start**.

3 COMPETITIONS MINIMUM

(event part of the World Championships programme in one category).

The requirement of competitions take into account any event's type represented at the World Championships, regardless of the number of nations at the start of those events.

<i>Example of possible minimum programme for a class 2 event</i>	
MEN ELITE	Keirin (5 nations at the start) → eligible for class 2 points (even with 5 nations represented, the registered class of the event determines the maximum applicable points scale).
WOMEN ELITE	Sprint (2 nations at the start) → not eligible for points
MEN JUNIORS	Sprint (1 nation at the start) → not eligible for points
With 3 categories, a maximum of 5 nations in one event and 2 competitions, such an event would be classified in class 2.	

OTHER ITEMS

REGIONAL GAMES

A UCI international commissaire is appointed to the events included on the calendar of the Regional Games. These events are subject to the payment of a calendar fee.

Points awarded for regional games depend on the number of participating national federations as stipulated in art. 3.3.010.

TRACK REGISTRATION FORMS

EXISTING EVENTS IN 2020-2021

The Organiser receives for each of their events a pre-filled form (PDF file) with specific information about the event as it appears on the draft calendar. The forms have been sent mid-march.

NEW EVENTS

For the registration of new events, extra forms can be obtained from the National Federation.

For the National Federations, a blank registration form, identical for all the Track Events, are available on the [Federation Extranet](#), **to be used exclusively for the registration of new events.**

For registration of new events, a [technical file](#) shall be transmitted together with the registration form.

All new international events will be registered in Class 2 into the UCI Track International Calendar for one year of probation.

RESULTS

We would like to remind you that the results of international events and National Championships must be sent under the procedure introduced on 1 January 2017.

REMINDER: LATE ENTRIES (after May 1st)

Following the update of the UCI article 3.8.001ter, late registrations will only be possible in Class 2. It is also reminded that to add a Cl2 competition to the UCI Track Calendar the deadline of 3 months shall apply (art. 3.8.001ter). As per the financial obligations, any modification (addition or removal of a race) shall be communicated 30 days before the event, failing that it will still be possible to add races but the class of the race will be CL2. The modification fees as per the Financial Obligations still apply.
